

The issue of BIPOC youth being disproportionately referred into the juvenile justice system has been identified as a significant public health concern.

Since 2020, there has been a surge in the number of young people entering the juvenile justice system, surpassing the capacity of staff and alternatives to incarceration.

# PRIORITIZING **OUR YOUTH**



• Prevention: Ensure youth do not enter a formalized Juvenile Justice System • i.e., Juvenile Hearing Boards

• **Diversion:** Prevent youth from going to community supervision or incarceration • i.e., Family Court Diversion Program

• Systems: Youth who are either on supervision or incarcerated • i.e., Probation or Training School

• Aftercare: Youth who are transitioning out or leaving the system • i.e., Reentry/Aftercare


# Racial and Ethnic Disparities in Rhode Island's Juvenile Justice System

During 2022, non-Hispanic Black youth made up 24% of youth at the Training School and 20% of youth on probation, while making up only 6% of the total child population.


Hispanic youth made up 42% of youth at the Training School and 37% of youth on probation, while making up 27% of the total child population.

## **Rhode Island's Detention and Probation Populations**, Calendar Years 2008–2022




# Racial and Ethnic Disparities in Rhode Island's Detention Population



# The Role of Juvenile Hearing Boards and Restorative Justice

## 7 TYPICAL STEPS OF A JHB HEARING



THE PROCESS

JHB hearing: Youth and guardian meet with community panel to agree on meaningful sanctions that hold the youth accountable, repair harm, & connect youth to services.

The result: Youth completes community-based requirements. JHB members check in on progress after 3-6 months. No criminal record at court!

## **JHB'S ARE A YOUTH DIVERSION PROGRAM**

### Youth arrested for lower-level violations are diverted -- steered away -- from "the system."

### **TRADITIONAL PROCESSING**

- FORMAL COURT APPEARANCE
- POTENTIAL INCARCERATION OR PROBATION
- COURT RECORD

### **JUVENILE HEARING BOARDS**

- HEARING WITH LOCAL COMMUNITY MEMBERS
- COMMUNITY SERVICE REFERRAL OR OTHER ASSIGNMENT
- NO COURT RECORD



## **DIVERSION PROGRAMS AT TIDES**

## Youth Transition Center (YTC) - Re-Entry Program

Helps youth to prepare for release from the RITS or meet the conditions of their probation

Emphasizing responsibility and prevention strategies to avoid re-entry into the Juvenile Justice System

\*Additional investments into this program will provide a trauma informed community based supervision program for justice involved youth\*

Prior to funding cuts in 2012, YTC had capacity to serve as a Day Reporting Center that would allow for community supervision of pre adjudicated youth as an alternative to detention in the RITS

# **Children's Mobile Crisis Response (CMCR)**

A brief intervention model with the goal of stabilizing acute crisis situations while providing assessment and referrals to appropriate treatment providers

Master level clinicians and behavioral assistants will work to prevent unnecessary police involvement and/or out of home placement

- 86% of the youth that received behavioral health services from CMCR that closed did not end up hospitalized or in a higher level of care.
- Tides is proud to say it has supported over 400 youth with crisis stabilization services since the program started in 2020.

## **PREVENTION PROGRAMS AT TIDES**

Serving ages 2 to 21, youth and their families will remain open approximately 30 days in order to help them stabilize and make a connection to needed services

# **Functional Family Therapy (FFT)**

# TFS has been a provider since 2017

Effective, short-term evidence-based family counseling service designed for 11-to-18year-old-youth who are at risk or have been referred for behavioral or emotional problems


\*Consideration should be given to fund these specialty programs and avoid a one size fits all approach to providing evidence based services to more acute youth\*

Works with a young person's entire family and extrafamilial influences to facilitate positive growth and development








## **Rhode Island Juvenile Hearing Board Cases 2022** Data is collected from police departments by Family Court.


